# **RVAA Motion #2**

Compliance Committee Motion #1: Recommend the RVAA review and vote on any limitations for the three regions who did not meet the minimum ROAS reporting requirements by the required deadline, per the policy approved by the RVAA. (Armson-Dyer/Bush)(6-0-2)

#### Rationale:

Per the ROAS Policy approved Oct 2021 (click here), three regions (Excelsior, Great Plains, Rocky Mountain) in the first round of the ROAS review (to be submitted by first quarter 2022) have not reached the minimum standards required by the policy in more than a year after the submission deadline. The compliance committee chair / designee has been in communication and have provided detailed assistance with no additional information provided to the committee on progress to completion. Per the policy "willful disregard for the minimum requirements may result in voice but no vote in RVAA Committees or RVAA General Sessions, or no vote in the RVAA Board Representative elections to the USA Volleyball Board of Directors."

Jen Armson-Dyer -Out of 10, 3 are currently not complete from the first round. Steve Bishop- 2 out of 3 regions surrendered their vote to the RVAA Chair prior to the RVAA meeting.

Steve Kenyon- When the deadline was given did the regions know their consequence if they did not comply?

Jen Armson- Dyer - The compliance recommended that action needed to be taken by the RVA Chair. April 17<sup>th</sup> and May 10<sup>th</sup> was communicated to all regions if they didn't complete by the deadline.

Rocky Mountain is suspending their vote for this meeting but would like to know, is it the appropriate sanction?
