**V. ASSEMBLY CHAIR REPORT**

**Reitinger**

Discussed filling the chair position for strategic planning. Bob Price has resigned. The RVAA need to discuss if they still plan on having strategic planning or if anyone would like to be appointed to that position. The RVAA will look into filling this position.

**Lisa DiGiacinto** is concerned that we are limiting people to one committee. Her fear is that when you restrict people from being in an assembly where they could be a positive force, we could go backward, and things won't be done well. It is very concerning to limit people to one place.

**Steve Bishop:** If we continue Online committees where we are allowed to attend multiple committees- Group 1 and Group 2 model Are we going to maintain with the structure or restructure the Group 1 and Group 2 where you can only serve on one committee in each group?

Andy Reitinger suggests to stimulate conversation through the group, stretch and challenge ourselves and exchange in the dialogue, have an open mind and be curious. Stay on topic, speak for ourselves not for the group, attack the problem not the person. It is okay to disagree, but it's not okay to blame or shame. Olympic Recap-

Historic sweep for Women's Indoor, Beach, and Paralympics. There were a lot of COVID issues that USAV handled behind the scenes. USAV has been working hard to capitalize on Operation Gold Rush by keeping the momentum of the Gold Medal Success. Jamie would like all the regions to send Laura Bush (Marketing Committee) what each region did to promote their region during the Olympic so he can share that with FIVB.

USOPC-

Has come out with mandating all employee, contractors, and athletes to be fully vaccinated to come into the facility. USAV is monitoring all options.

All staff reports from all departments and the questions they got prior to the meeting, they have sent out as well. Open to questions.

**Q: Dan Ames:** How are we identifying regional instructors for Education Services? How will it be paid?

**A: Dave McCann:** USAV is in the process of the relaunch of Education they will be identifying a national faculty going to consist former CAP instructors, and other recommendations by staff and the education committee. We are in the first wave of the national faculty members. They will be trained for several weeks how to train a trainer model. Each Region will have the opportunity to identify the specific instructors within their region to deliver modules and instruction to coaches of their region. National Faculty will be arranged and paid by USAV here in Denver and online. The hope for the growth of the program is zonal training. USAV will incur all the costs to get the National Faculty out to the zonal but then all other cost will be back to the region.

**Q: Andy Reitingner:** With the people that are being considered for the National faculty members but no longer USAV, do we have any leverage on getting them back solely as a USAV National faculty member?

**A: Dave McCann:** They will all have to be USAV Members, and there is a file process to identify the best group of faculty to support the USAV.

Questions were asked about how the faculty will be hired and what requirements will be set in place. Dave McCann expressed that the committee would reach out to each region to make sure the cadre is in good standings for USAV. The National faculty cadre will cover beach, indoor, sitting, and para beach. Each National faculty cadre will at this time register within their designated region.

## XI. VENDOR REPORTS

### a. NCSI

### b. EPIC – Jennifer Rains and Sean Lankey

**Overview:** EPIC is continuing to look at a new emerging company and will continue to look at a midterm move if it is beneficial for the Regions. USAV has a great relationship with their carrier because the lost history has not been significant. Within the last 5 years, there has only been about 50 claims that were paid out on the liability policy. This was very beneficial when renewing our policy this term. Over 20+ markets were approached and only a few provided quotes.

In May, the prior membership rate for liability would have been \$5.06 per member. With all the changes, the rate went up to \$7.42 per member.

Participant Accident is in line of what we have had in the past. It is the General liability, Umbrella liability, and the abuse coverage that have been the impact in the market.

**Cyber liability program:** The Cyber premium remained flat but has an 11/1/2021 expiration date. EPIC will send out a reminder of who has not responded to the renewal.

**Regional D&O Insurance:** EPIC is working to finalize the renewal options for the Regional D & O insurance. The D & O and EPL market are very challenging right now. The renewal premium quote was \$72,000 for the 40-region policy. Market conditions have affected this price, the D & O is at \$15,000. The insurance company will increase retention levels so that the D & O deductible does not increase. There are certain regions that will need to implement a higher retention level for employment practices liability that would be \$50,000-75,000. They have tiered it based on revenue, employee counts, claims history and how you fall into the tier.

**Q: Jen Armson-Dyer:** Is there a way that the RVA can provide a safeguard to help drop the deductible for some regions that cannot afford that deductible?

**A: Jennifer Rains:** Each region is different in size and operations, so we must think of different resources and will have to take advantage of that to help some of the risk management process to setting funds aside to help a region with that cost.

**Q: Sandy Abbinanti:** Is there a way for a region to get their own D & O?

**A: Jennifer Rains:** Yes, you can separate the insurance policy. A region can go out and purchase their own D & O, but it will affect the underwriter's position as far as coverage and protection. D & O is not required by USAV. It will likely not change the pricing difference if a couple regions want to get their own.

**A: Sean Lankey:** The group plan is in uncharted waters to have a vital group program. What EPIC has built is custom to USAV. If a region decides they do not want the D & O then we must be selective if they walk away. We can't just let them back in due to our own risk and liability. There should be rules and regulations in place, so that if a situation happens regions cannot just run back to this coverage.

AAU has reached out for us to find them insurance and will not do business with competitors of USAV. **Jennifer Rains:** Keep making sure that you have the evidence that it was not a USAV sanction and approved by the region.

**A: Sean Lankey:** Comparable in size with the normal range.

**Q: Steve Bishop:** Can we pull claims filed by people with reduced memberships to see the statistics on the percent of them filling claims?

**A: Jennifer Rains:** Yes, we can explore further and get that information.

**Q: Keith Murlless:** Can we create some sort of informational flyer for our parent level members of the extra benefits?

**A: Jennifer Rains:** We can create a flyer proving what we can offer.

If a conflict exists or occurs within the approved geographical boundaries of an RVA, the Commissioner or principal representative may prohibit the sanctioning of events and activities within these approved boundaries by the registering RVA.
- iv. Registration and / or sanctioning disputes shall be referred to the Ethics and Eligibility Committee of the RVAA for resolution.

Proposed wording Article IV.7.e

e. WHERE TO REGISTER TEAMS

- i. Teams. Each team participating in any RVA, or Corporation sanctioned activities shall be considered registered with the Corporation by registering with its respective RVA.
- ii. Teams shall register in one of the following categories:
- iii. Regular. Registration required of teams composed either entirely of regular athletes or a composite of regular, junior volleyball and/or "other" athletes.
- iv. Junior Volleyball. Registration required of teams composed entirely of junior volleyball athletes.
- v. Each team shall register with the RVA in whose area the team representative resides.

f. WHERE TO REGISTER CLUBS

- i. Each Club, consisting of one or more teams, shall be considered registered with the Corporation by registering with its respective RVA. Individuals and teams shall register in the same RVA in which the Club is registered. Each Club shall register with one RVA, as determined by the principal address of the designated club leadership and where the majority of its members reside.
- ii. EXCEPTION: A club composed of individuals primarily residing in one RVA may request to register in an adjacent RVA with the written permission of the Principal Representatives of both RVAs.
- iii. The registering RVA shall be empowered to govern activities within its geographic boundaries and of Individuals, Team and Clubs registered with the RVA, for the duration of its registration. If a conflict occurs within a RVA's approved geographical boundaries, the Principal Representative may prohibit the sanctioning of events and activities within these approved boundaries by the registering RVA.
- iv. Registration and/or sanctioning disputes shall be referred first to the administrative RVA as described in 5.02 or where party seeks to register or sanction an event, then to the Ethics and Eligibility Committee of the RVA Assembly, only to determine whether due process was provided. **Motion Carries 30-2-8**
